Economic Development Strategic Plan for Volusia County, The County retained SPG to update its past Florida. economic development plans in light of the creation of a new County EDO. SPG conducted over 70 face-to-face interviews, four regional charrettes throughout the County, two County workshops and a final Public Hearing on the Strategic Plan and its implementation program. The County's commitment to economic development increased from \$267,000 to \$2.1 million.

The \$100 million Implementation Plan covers six major goals including: Developing and Implementing a Unified Approach to Economic Development; Business Development and Expansion; Tourism Enhancement and Expansion; Workforce Development; Community Development; and Maintaining and Enhancing the Quality of Life and Environment of Volusia County.

Deltona Economic Development Plan



Description of Services: The work on this five year Strategic Economic Development Plan was undertaken in conjunction with the City's Economic Development Board and city staff, who were ultimately be responsible for managing and implementing the plan.

As a part of the work program, SPG developed a socio-economic profile of the City of Deltona, Volusia County, and selected other cities and counties in the regional area for comparative purposes. This work effort was designed to establish an overview of the City. In addition, workshops with the Economic Development Board were held on August 18 and September 10, 2007, to obtain input on community issues, goals, objectives, and strategies for the plan. This effort resulted in a general consensus, refinement, and prioritization of 28 objectives, and 44 strategies.







HIFI COMMERCE PARK: Hunter Industrial Facilities, Inc., Dayton-Houston, Texas

SPG personnel participated as Development Consultant for a 6,000-acre plus, mixed-use, commercial/industrial project featuring on-site disposal and storage of hazardous waste materials in salt dome formation located in Dayton, Texas.

The planning and permitting process spanned a three-year period during which a complete land use development plan, financial plan, marketing program, and regulatory community input process was established and implemented.

Numerous studies were undertaken to establish the community benefits and liabilities associated with the project, including fiscal and employment impact analysis, environmental impacts, social needs assessments, and public safety concerns. Land use planning/re-use industrial identification was provided to determine industries that would be impacted by hazardous waste disposal issues and their particular land use needs.

St. Petersburg's UIRA Economic Positioning Program, - SPG in association with RMPK Group, was retained by the City of St. Petersburg to reevaluate its downtown area, the City's historic African-American neighborhood / community. This five square mile area was reevaluated and SPG prepared a revitalization program aimed at reversing the areas residential base and capturing increased commercial/retail businesses. SPG provided extensive market and demographic statistics including market potential for 1, 3, 5 mile radii as well as estimates of buying potential within the study area as well as its supporting region. Recommendations included developing a strong ministerial alliance, creation of one or more CDCs and mechanisms aimed at increasing the economic development potential of the residents and the area.

VIRGIN ISLANDS

Economic Development Strategy, United States Virgin Islands. SPG was selected after international competition to devise a strategic Economic Development Program for each of the Islands of St. Thomas, St. Croix, and St. John (separate plans). The overall goal of this effort was to develop a realistic plan to diversify and expand local job creation and develop implementation procedures to carry out the program. This program was developed to work in tandem with the Islands Long Range Growth Management Plans; the first attempt to combine Comprehensive Land Planning and Economic Development in the Caribbean.

This project was funded by an EDA grant.





ECONOMIC DEVELOPMENT

Our staff has participated in over 100 industrial site selection research studies since 1974. These studies have focused on sites ranging in size from less than 100 acres to over 4,000 acres. We have extensive experience in the identification and evaluation of industrial site assets and constraints. SPG is one of only three firms internationally that has developed detailed proprietary economic development and industrial targeting models that can assist governments strategically plan their economic development programs. Our staff has assisted over 40 local and regional governments and public/private agencies create successful economic development strategies resulting in the creation of over 100,000 new jobs and \$14 billion in new capital investment. This experience has been used to help both public and private sector clients embark on successful, financially feasible industrial development programs. Representative examples of our experience in this area are described below:

Atlanta, Georgia 1996 Olympic Games Initial Fiscal Analysis - Strategic Planning Group, Inc., partnered with the University of Georgia to assist with the bid for the 1996 Olympics by assessing the economic impact of hosting the Summer Olympic Games in Atlanta. The initial Economic Impact Study concluded that there would be an estimated total output impact of about \$3.5 billion. Volusia County Economic Development Strategy, Volusia County, Florida—The County retained SPG to update its past economic development plans in light of the creation of a new County EDO. SPG conducted over 70 face-to-face interviews and four regional charrettes throughout the County, two County workshops and a final Public Hearing on the Strategic Plan and its implementation Program. The strategic plan is based on a strong public-private partnership. The public sector includes the County's 17 municipalities, the County Council, Volusia Council of Governments, The Workforce Development Board, School Board, Hire Education Consortium and local Chambers of Commerce.

Manatee Economic Development Council Economic Base and Target Industry Study, Manatee County, Florida—SPG was retained by the Manatee Economic Development Council (EDC) to conduct an Economic Base Study for Manatee County. SPG staff worked closely with the EDC and Manatee County government in the preparation of this study. The project is designed to assist the Economic Development Council with its economic initiative programs and will identify activities needed to maintain a strong and balanced economy through business retention, expansion, and recruitment.

Economic Development Program for Pasco County, Florida—SPG was commissioned by the Economic Development Council of Pasco County to develop an overall economic development strategy for the County. The study was prepared for the Withlacoochee Private Industry Council which is comprised of members representing the counties in partnership with the five-member Consortium of Local Elected Officials. Washtenaw County Economic Development Strategy and Targeted Industries Study, Washtenaw County, Michigan. (EDA Title IX funded grant). This plan focused on restructuring the county's historic economic base, which was highly dependent on a strong military and automotive industrial base, to a more knowledge-based economy (home to University of Michigan). Resulted in the reuse of the General Motors Willow Run Assembly Plant (a 2.68 million square foot building).





Visions 2000 Program, North Miami, Florida. SPG was retained by the City of North Miami to conduct its Visions 2000 program. Duties included performing background research, preparing long-term projections, and acting as facilitator for their Visions Committee.

Jacksonville Economic Development Study, Jacksonville Chamber of Commerce and the Committee of 100, Jacksonville, Florida—This comprehensive study of Jacksonville's ability to attract and maintain viable commercial and industrial development included preparation of a community profile, analysis of the area's strengths and weaknesses, identification of target industries, and a survey of manufacturing firms to collect wage and benefit data. The community profile identifies and evaluates demographic, economic, labor force, transportation, and community service conditions that affect the economic development potential of Jacksonville. The analysis of development strengths and weaknesses identified the actual and perceived liabilities and assets that decision makers (e.g., business executives, professional developers) associate with Jacksonville. The target industries study identified the most appropriate types of industries to be south for Jacksonville's economic development program, while the wage and benefit survey provided information needed to successfully implement the economic development program.





Coosa River Industrial Targeting Study, U.S. Army Corps of Engineers, Mobile District, Mobile, Alabama—SPG staff developed a computerized industrial targeting model using four-digit SIC codes to facilitate identification and assessment of probable industrial shifts in ten counties resulting from changes in the barge shipping industry. The model matches industry potential with local resources, including energy, transportation, labor force characteristics, site availability, and other variables relevant to attracting industrial investment.

Lee County Economic Assessment, Economic Development Committee of Lee County, Inc., Ft. Myers, Florida— SPG staff was retained by the Economic Development Committee of Lee County, Inc. to provide background information and commentary to guide the Lee County government in developing economic assumptions for a new comprehensive plan. This report assessed and profiled employment and economic components, and examined market characteristics and trends affecting local economic development. Detailed employment projections for the time period from 1985 through 2005 were developed using four different scenarios: moderate change scenario, unconstrained historic trend, constrained historic trend, and adjusted trend. An employment sector analysis was performed to calculate potential manufacturing employment growth, as well as transportation, communications, utilities; and wholesale trade employment opportunities over the time period.

Industrial Free Trade Zone Analysis, Arab Republic of Egypt — This strategic planning study identified industrial free trade zone development potentials that maximize the economic benefit to Egypt. A cost-benefit analysis which addressed shadow pricing was used to assess the economic feasibility of industrial development at free trade zones, while a fiscal analysis was used to assess the financial benefits the government would realize from development of the free trade zones. An industrial targeting study analyzed the specific opportunities (i.e., market demand, material inventories, labor availability, technology, capital, and raw materials availability) in Egyptian free trade zones for 250 industries to identify 21 of the most suitable target industries.

BioMedical Economic Development Strategy for the First Coast, Florida - SPG prepared the State of Florida's first Biomedical Economic Development Targeting Study for Jacksonville's Economic Development Council and the Private Industry Council. As a result of the study, Jacksonville worked closely with the University of Florida and Mayo Clinic to strengthen the basic research being conducted with the Region and the Region has developed into one of the State's three biomedical regional "clusters."

Economic Development Program for Clay County, Florida - SPG was retained by the County Commission and the County's Economic Development Council to prepare a Countywide Economic Development Program to guide the County's Comprehensive Plan. The Plan contained a Business Plan and Target Industry program to assist the County in attracting industry and business, thereby reducing the daily out-migration of workers to Duval (Jacksonville) County. Clay County has recently landed over 7,500 new, high-paying jobs as a result of the implementation of the County's strategy.

Dayton, Texas - HiFi Tech - The planning and permitting process spanned a three-year period, in which time a complete, land-use development plan, financial plan, marketing program, and regulatory community input process was established and implemented. Numerous studies were undertaken to establish the community benefits and liabilities associated with the project, including fiscal and





employment impact analysis, environmental impacts, social needs assessments, and public safety concerns. Land-use planning and reuse industrial identification was provided to determine industries impacted by hazardous waste disposal issues and other particular land use needs. The consultants represented the client and project at major, national real estate and environmental trade shows.

Visions 2000 Program, Putnam County, Florida. SPG was commission by Putnam County to act as facilitator in its Visions 2000 Program. The Visions Program consisted of numerous meetings in the larger communities around the County, and developed a very formal vision of the County within eight topic areas ranging from economic development, to intergovernmental coordination. The Visions Program was adopted by the County's Planning Commission and the Board of County Commissioners.

Tarpon Springs, Florida Economic Repositioning Program - SPG was part of a team retained by the City to re-evaluate its downtown and develop a new Master Plan for the small CBD. SPG had prepared the historic preservation element of the Dock area, which is the area's major tourist attraction. The reposition program led the City to link the downtown area with the docks to create an overnight tourism destination area and to link the downtown arts colony with the other area attractions.

Titusville, Florida Economic Development Feasibility Study - The scope of work was divided into 5 major tasks: 1) Identification of Potential Goals and Objectives for the Area; 2) Profiles the Area's Economy and Market Demographics; 3) Evaluate Market Conditions and Specific Uses and 4) Define Suitable and Market Supportable Economic Environments.

Economic Development Organization Study for Volusia County, Florida - SPG was retained by the County Council to analyze how the County as a whole was organized, to conduct economic development and make recommendations for improvement. The Study resulted in the creation of a new Economic Development Organization housed within County Government. As a result of the restructuring economic development responsibilities, County funding for economic development increased from \$264,000 annually to over \$2.1 million annually.

Economic Development Strategic Plan for Volusia County, Florida -The County retained SPG to update its past economic development plans in light of the creation of a new County EDO. SPG conducted over 70 face-to-face interviews, four regional charrettes throughout the County and, two County workshops and a final public hearing on the Strategic Plan and its implementation program. The stakeholders included the County's 17 municipalities, the County Council, Volusia Council of Governments, The Workforce Development Board, School Board, Higher Education Consortium, business leaders, citizens and local Chambers of Commerce. The final Implementation Program contained six goals, 37 objectives and 237 strategies defined in detail. All goals, objectives and policies required (over 200), the implementation time frame, responsibilities, cost and funding sources were also defined. It should be noted that there is considerable overlap between goals, objectives and strategies and that responsibility for the objectives/strategies involves a host of public and private stakeholders. The plan could only be successful with cooperation and commitment among all parties.

Walton County, Florida Economic Analysis - Strategic Planning Group, Inc. was retained by Walton County Tourist Development Council to conduct a Tourism Economic Impact Study of the County. Tourism is the single largest economic sector within the county – accounting for approximately 60% of





the county's revenue (including the General Fund and School Board Funds). SPG was able to document the flow of tourism dollars throughout the economy and the importance of using tourism generated revenues to support related facilities and services.

Winter Haven Redevelopment Plan and Economic Repositioning Strategy, Florida - SPG was retained by the City of Winter Haven to develop tan economic repositioning study of the City's downtown area. This study resulted in the City establishing a Downtown CRA. The repositioning study demonstrated the need to redevelop the old Winter Haven Mall (which has now been redeveloped) and connect various parts of the downtown area into a coherent and identifiable area.

Industrial Free Trade Zone Analysis, Arab Republic of Egypt. This strategic planning study identified industrial free trade zone development potentials that maximize the economic benefit to Egypt. A cost-benefit analysis which addressed shadow pricing was used to assess the economic feasibility of industrial development at free trade zones, while a fiscal analysis was used to assess the financial benefits the government would realize from development of the free trade zones. An industrial targeting study analyzed the specific opportunities (i.e., market demand, material inventories, labor availability, technology, capital, and raw materials availability) in Egyptian free trade zones for 250 industries to identify 21 of the most suitable target industries.

Economic Development Strategy, United States Virgin Islands. SPG was selected after international competition to devise a strategic Economic Development Program for each of the Islands of St. Thomas, St.Croix, and St. John (separate plans). The overall goal of this effort was to develop a realistic plan to diversify and expand local job creation and develop implementation procedures to carry out the program. This program was developed to work in tandem with the Islands Long Range Growth Management Plans; the first attempt to combine Comprehensive Land Planning and Economic Development in the Caribbean.

Fiscal Plan and Economic Impact Analysis, the 1996 Olympic Games in Atlanta, Georgia. SPG staff served as the co-author of the Fiscal Plan and Economic Impact Analysis for the 1996 Summer Olympic Games held in Atlanta. The study, conducted in conjunction with the University of Georgia, identified the types of expenditures (capital, visitor, etc.) for each year between 1992 and the year of the Games in 1996. SPG has subsequently designed a research program for the Atlanta Committee for the Olympic Games (ACOG) to measure, monitor, and manage the economic impacts over this period.

Coosa River Industrial Targeting Study, U.S. Army Corps of Engineers, Mobile District, Mobile, Alabama. SPG Staff developed a computerized industrial targeting model using four-digit SIC codes to facilitate identification and assessment of probable industrial shifts in 10 counties resulting from changes in the barge shipping industry. Ormond Beach Economic Development Strategic Plan- Strategic Planning Group, Inc prepared the highly successful Ormond Beach Economic Development Strategic Plan which was based on a community Vision Process to establish a five year strategic process for the City. SPG continues to assist the City in the implementation of this plan, assist in documenting Fiscal Impacts to the City as a result of growth as well as assisting with the marketing of the program
